GROUP A	Intervention in cross-border situations – in response to a state, or actors based within it, acting or threatening to act unacceptably against other states, in the process breaking international law or accepted norms of international relations. Questions such as those from 1-5 in the terms of reference.
GROUP B	Intervention in single-state situations – in response to flagrant human rights violations by a state against its own people, or to a humanitarian disaster where a state is failing to act effectively. Questions such as those from 6-11 in the terms of reference.
GROUP C	Defensive strategies that are or should be available to a state in response to legally or morally unacceptable intervention in its affairs by another state or states, whether that be declared, undeclared or uncertain. Questions such as those from 12-18 in the terms of reference.
	The division into separate groups is necessarily arbitrary. While concentrating on the main topic devolved to them, groups should not worry unduly about overlap where that seems useful.

Finally, for anyone who would like to convene a small-group in order to continue the discussion after lunch, the Velvet Room is at your disposal (maximum capacity 12 people), and coffee can be arranged, upon request.

NOTE 2: Luggage
